PARK USE AND INDEMNITY POLICY

Driving on the grass is prohibited.

RESERVATIONS: Reservations are accepted on a first come/first served basis. Fees and deposits are set by the City of Ouray.

ALCOHOL: Beer, wine, and other spirits are allowed with prior approval and only when served with food

The Ouray City Code requires that in order to possess or consume alcoholic beverages on City property, the applicant must make such request for review and approval by the City of Ouray. If you are having a private party with alcoholic beverages served to your guests, please prepare a letter with the following information and send to the City of Ouray no later than 3 weeks prior to the event:

- * Name, address and phone number of the applicant
- * Nature of the event (e.g., wedding reception, family reunion)
- * That the event is private (i.e., by invitation only) and not open to the public
- * If there are minors (i.e., under 21 years of age), a statement that they will not be allowed to possess or consume alcoholic beverages
- * If no minors will be attending, include a statement to that effect

NOISE: No excessive noise. All noise must comply with the City of Ouray Noise Regulations, Section 10-44 of the City Code. A band is allowed if previously approved by the City and noise is reasonable and kept under control.

TENTS: No overnight camping is allowed. Awning tents are allowed with approval. Damage to the grass or sprinklers will be assessed against your deposit. No stakes of any kind are allowed in the grass area without prior approval.

POLICY OF INDEMNITY: Applicant agrees to hold harmless, defend, and indemnify, the City of Ouray, its officers, agents, or employees on account of any claim made or adjudged arising out of this permit, or the use of the premises granted herein. Applicant shall maintain and use the premise at all times in conformity with City ordinances and other applicable laws, keep it in a safe and clean condition, and allow no nuisance to be created by virtue of the said use.

Applicant shall remove all of their property and structures from the premises at the end of the event. Applicant shall be responsible for the cost of repair for any damage to City property and shall restore the premise to its preexisting condition or it shall be restored to preexisting condition at applicants expense.

The City may revoke this permit at any time as deemed appropriate at the City's discretion. In such event, all property of the applicant shall be removed and preexisting conditions restored at applicants expense.
