

Sign Area: Is the area of the structure upon which the sign message is displayed. The face area of a sign painted or hung on a wall of a building, or on an awning, shall include all the area within a perimeter surrounding all words, symbols, designs and coloring, distinctive from the wall or awning upon which it is painted or hung (figure 1). The area of signs with irregular shapes shall be the entire area within a single continuous perimeter of not more than eight (8) straight lines enclosing the extreme limits of the sign. If a sign has two (2) faces, both sides shall be included in the sign face area.
