

**A DECLARATION OF CITY OF OURAY, COLORADO STAGE II WATER  
RESTRICTIONS  
(DECLARATION NO. 3, 2018)**

**WHEREAS**, the Mayor of the City of Ouray, Colorado (Mayor) pursuant to the City of Ouray Charter Section 2.3 (A) and City of Ouray Code Section 2-8 has the authority to declare a local disaster emergency to exist when, in the Mayor's opinion, there is an occurrence or imminent threat of widespread or severe damage, injury, loss of life or property, resulting from any cause of human origin, including but not limited to lack of water resources,

**WHEREAS**, the Mayor believes the need to declare Stage II Water Restrictions; and

**WHEREAS**, these restrictions will remain in place until further notice and unless otherwise revised or rescinded by City Council; and

**NOW, THEREFORE, BE IT DECLARED BY THE MAYOR OF THE CITY OF OURAY, COLORADO**, that:

STAGE II WATER RESTRICTIONS:

Mandatory Restrictions: Demand exceeds system capacity

- A. No irrigating between the hours of 9:00 am and 6:00 pm, or when windy, in order to minimize evaporation, and anytime on Mondays.
- B. Properties located on the SOUTH side of 7<sup>th</sup> Avenue – irrigate only on Tuesdays and Saturdays.
- C. Properties located on the NORTH side of 7<sup>th</sup> Avenue – irrigate only on Wednesdays and Sundays.
- D. City Parks irrigation limited to the same as properties north and south of 7<sup>th</sup> Avenue.

THE FOLLOWING ARE PERMITTED UNDER STAGE II WATER RESTRICTIONS:

- A. Drip systems, soaker hoses, tree tubes and use of hand-watering containers.

PENALTIES FOR VIOLATION:


- 1. A first violation shall be subject to a written warning as described in section 9-11-F;
- 2. A second violation by the same individual, regardless of the location of the violation, shall be subject to a fine of Three Hundred Dollars (\$300.00) plus court costs;
- 3. A third or subsequent violation by the same individual, regardless of the location of the violation, shall be subject to a fine of One Thousand Dollars (\$1,000.00) or by imprisonment of not more than ninety (90) days, or by both, plus court costs, provided however, that no person under the age of eighteen (18) years may be sentenced to any term of imprisonment.

Now, therefore, I, Pamela J. Larson, Mayor of the City of Ouray hereby declares: STAGE II WATER RESTRICTIONS effective June 8, 2018 8:00am.
